You are also invited to attend the Pre-Bid Meeting at Owner’s Site Office and Village (OSOV), Hat Gnuin Village, Bolikhan District, Bolikhamxay Province, and participate on a site visit on **Monday 29th May 2017 at 2:00pm**.
