



INVITATION FOR BIDS

“Reconstruction of Suspension Bridge in 2UR, Thathom District, Saysomboun Province”

The Nam Ngiep 1 Power Co. Ltd. (hereinafter called “the Owner”) has been established to develop the Nam Ngiep 1 Hydropower Project (“Project”). SEALED bids should be prepared separately for the technical and financial proposal (One Original and One Copy), and submitted in one sealed envelope, duly signed by the authorized personnel of the bidder and clearly marked “Confidential” ORIGINAL OR COPY and **“Proposals for Reconstruction of Suspension Bridge in 2UR, Thathom District, Saysomboun Province”**

You are also invited to attend the Pre-Bid Meeting at Thaviengsay Office of NNP1PC, Thathom District, Saysomboun Province and participate on a site visit on **Friday 22nd, May 2020 at 2:00pm**. Bids must be delivered to the address below at or before **17:00pm, Monday 8th June 2020**. Late bids will be rejected and returned unopened to the bidders.
