



## **INVITATION FOR BIDS**

### **“Security Services at the Owner’s Site Office and Village”**

Nam Ngiep 1 Power Company Limited (hereinafter called “Owner”), co-owned by KPIC Netherlands, a subsidiary of Japan’s Kansai Electric Power, EGAT International of Thailand, and the Lao Holding State Enterprise, was established to develop the Nam Ngiep 1 Hydropower Project (“Project”). SEALED bids should be prepared separately for the technical and financial proposal (**One Original and One Copy**) and submitted in **one sealed envelope** and duly signed by the authorized personnel of the bidder and clearly marked “**Confidential**” ORIGINAL OR COPY and “Security Service for OSOV”.

You are also invited to attend the Pre-Bid Meeting at the Owner’s Site Office and Village, Bolikhan District, Bolikhamxay Province and participate in a site visit on **Tuesday 8<sup>th</sup> December 2020 at 10:00am**. Bids must be delivered in the **hard copies** to the address below at or before **17.00 pm, Lao local time on Tuesday 15<sup>th</sup> December 2020**.
