The late submission of bid will be rejected and returned unopened to the bidders.

The rate quoted by the bidder shall be fixed for the duration of the contract. The quoted price shall be in **Lao Kip (LAK)** inclusive of all taxes and duties, and delivery fee to the Project site.

The Price Proposal shall remain valid for a period of **30 days** after the deadline for submission.
