“Pest Control Service on NNP1PC Project”

The Nam Ngiep 1 Power Co. Ltd (hereinafter called “The Owner”), co-owned by KPIC Netherlands, a subsidiary of Japan’s Kansai Electric Power, EGAT International of Thailand, and the Lao Holding State Enterprise, was established to develop the Nam Ngiep 1 Hydropower Project (“Project”). The Owner is now operating a 290-MW Project in Bolikham District, Bolikhamxay Province in order to provide clean renewable electricity and contribute to poverty reduction in Laos. As part of our Project, The Owner plans to select **an eligible Contractor/Company** to provide a service for **“Pest Control at Main Power Station (MPS), Re-regulation Power Station (RRPS) and Dam Control Center”** (“the Work”).

Bidding will be conducted through Request For Quotation (RFQ) procedures. Interested bidders must provide information indicating their qualifications that include but not limited to Contractor/Company profiles in accordance with the format provided by the Owner **“Request for Quotation Form”**.

The Owner may cancel the bidding process at any time for any reason, and the Owner is neither bound to accept any quotations that The Owner may receive nor required to invite any contractors/companies to submit the quotation for the Project without any financial obligations or liabilities to any bidders.

The quotations shall comprise of the following but not limited to:

- Price quotation
- Copy of Valid Business License
- Copy of Valid Tax Certificate

The Interested Contractor/Company must submit the quotation in **Lao kip in the sealed envelope**, duly signed by the authorized personnel of the bidder and clearly marked **“Confidential”** with title **“Quotation for Pest Control on NNP1PC Project”**. Interested eligible bidders may obtain full set of bidding documents by submission of writing application (email) to the address below during office hours.

Interested bidders are invited to attend the Pre-Bid Meeting via Video Conference on **Tuesday, May 10th, 2022 at 10:00am**. Bids must be delivered in the **hard copies** to the address below by or before **Friday, May 13th, 2022 at 17:00pm**. Late bids will be rejected and returned unopened to the bidders.
