



## REQUEST FOR QUOTATION

### “Car Leasing”

The Nam Ngiep 1 Power Co. Ltd. (hereinafter called “The Owner”), co-owned by KPIC Netherlands, a subsidiary of Japan’s Kansai Electric Power, EGAT International of Thailand, and the Lao Holding State Enterprise, was established to develop the Nam Ngiep 1 Hydropower Project (“Project”). The Owner is now operating a 290-MW Project in Bolikhan District, Bolikhamxay Province in order to provide clean renewable electricity and contribute to poverty reduction in Laos. As part of our Project, The Owner invites bidders of authorized dealers in Laos to participate in the bidding and submit **a Sealed Quotation** to provide “Car Leasing” (“the Service”) by submitting the following document:

#### **The quotations shall comprise of the following but not limited to:**

- Price quotation,
- Copy of Valid Business License in 2021, and
- Copy of Valid Tax Certificate in 2021

#### **Scope of works:**

- Two brand-new 4WD Fortuner of 2.8 diesel engine with automatic transmission gear manufactured in 2022 with no more than 100 Km,
- The cars will be mainly used in but not limited to Bolikhan District, Bolikhamxay Province, Xaysomboun Province and Vientiane Capital,
- Self-drive,
- The lease period is at least five years from September 1<sup>st</sup>, 2022 with an option to buy out during a lease period, and
- The full set of quotation form can be obtained upon request by email or written application to address below.

The Sealed Quotation must be delivered in the **hard copies (Original and two Copies)** and duly signed by the authorized personnel of the bidder and clearly marked “**Confidential**” with title “**Quotation for Car Leasing**” to The Owner’s office address below **by or before 17:00 (local time), Friday, 19<sup>th</sup> August 2022**. Late submission will be rejected and returned unopened to the suppliers.

The quotation by the bidder in **Lao Kip** shall be fixed for the duration of the contract and remain valid for a period not less **than 60 days** after the deadline for submission.

The Owner may cancel the bidding process at any time for any reason, and the Owner is neither bound to accept any quotations that The Owner may receive nor required to invite any suppliers/companies to submit the quotation for the Project without any financial obligations or liabilities to any bidders.
