The Owner is now operating a 290-MW Project in Bolikhan District, Bolikhamxay Province in order to provide clean renewable electricity and contribute to poverty reduction in Laos. Assignment Title: Water Samples Analysis Service

- Laboratory Service License with minimum of 5 years of experience on water samples analysis service.
- Familiar to the Standard Methods for The Examination of Water and Wastewater, APHA, AWWA, WEF, 23rd
 Edition, 2017.
- Excellent time management skills with an ability to deliver high-quality output in a timely manner.
- Ability to the write reporting in English.
