



## **INVITATION FOR BIDS**

### **“Security Services at the Owner’s Site Office and Village”**

Nam Ngiep 1 Power Company Limited (hereinafter called “Owner”) has been established to develop the Nam Ngiep 1 Hydropower Project (“Project”), co-owned by Kansai Electric Power of Japan, EGAT International Company Limited and Lao Holding State Enterprise, is operating a 290-MW power plants to provide clean renewable electricity and contribute to poverty reduction in Laos. As part of our Project, the “Owner” plans to select “Security Service Provider” to implement the security service at the Owner’s Site Office and Village (OSOV). The Owner invites interested bidders to complete the bidding process for the Services by submitting a technical and financial bid (the Proposals). Sealed bids should be prepared separately for the technical and financial proposal (**One Original and One Copy**), and submitted in **one sealed envelope**, duly signed by the authorized personnel of the bidder and clearly marked “**Confidential**” ORIGINAL OR COPY and “Security Service for OSOV”.

Interested bidders are invited to attend the Pre-Bid meeting at the Owner’s Site Office and Village (OSOV), Hatgnuin Village, Bolikhan District, Bolikhamxay Province **on Friday 19<sup>th</sup> July 2024 at 10:00am**.
