

REQUEST FOR EXPRESSION OF INTEREST

"General Waste Management and General Landfill Maintenance at the NNP1 Project"

The Nam Ngiep 1 Power Company Limited (hereinafter called "the Owner"), co-owned by KPIC Netherlands, a subsidiary of Japan's Kansai Electric Power, EGAT International Company Limited, and the Lao Holding State Enterprise, was established to develop the Nam Ngiep 1 Hydropower Project ("Project"). The Owner is now operating a 290-MW Project in Bolikhan District, Bolikhamxay Province in order to provide clean renewable electricity and contribute to poverty reduction in Laos. As part of our project, the "Owner" plans to select an eligible company to provide "General Waste Management and General Landfill Maintenance at the NNP1 Project" ("the Service") by inviting eligible companies to submit a technical and financial proposals. Sealed proposals should be prepared separately for the technical and financial proposal (One Original and One Copy), and submitted in one sealed envelope, duly signed by the authorized personnel of the bidder and clearly marked "Confidential" ORIGINAL OR COPY. Interested eligible bidders may obtain full set of bidding documents by submission of writing application (email) to the address below during office hours.

Interested bidders are invited to attend the Pre-Meeting at the NNP1 Project site, Hatngiun Village, Bolikhan District, Bolikhamxay Provovince, on **Tuesday May 16th**, **2023 at 10:00am**. Bids must be delivered in the **hard copies** to the address below by or no later than **Tuesday May 30th**, **2023 at 17:00pm**. Late bids will be rejected and returned unopened to the bidders.
